Recycling Yards: Targets for Burglaries and Armed Robberies

Scrap metal recycling yard operators are often victims of crime. Yards are targeted for burglaries and thefts for the valuable scrap metal taken in each day. Thieves have been known to steal scrap at night and return to the same yard the next day to sell back the stolen metal. While this may be seen as a property crime and even "the cost of doing business," operators and their employees, as with other cash businesses, are often times victims of violent armed robberies, a number of which have resulted in shots fired and victims injured.

Recycling yard operators are warned to take precautions and be vigilant, especially when opening and closing for the day; times when they might be most vulnerable. Law enforcement can be cautioned that scrap metal recycling is largely a cash business. Cash and valuable scrap metal, the objective of an April armed robbery in New Jersey, puts operators, their employees, and customers at risk for armed robbery.

Metals Theft Training Available

In addition to the law enforcement tools accessible at www.ScrapTheftAlert.com and www.StopMetalsTheft.org, ISRI provides metals theft training and education at law enforcement venues across the country. While not a "how to" in investigating metals theft, information is provided regarding yard operations, metals identification, state statutes, the impact of metals theft, and ISRI resources and cooperation between the recycling industry and law enforcement.
