StopMetalsTheft.org

In June, ISRI launched a new web site in the fight against metals theft. The site, StopMetalsTheft.org, provides law enforcement, prosecutors, and the recycling industry, with online tools to aid in the effort. The site's home page also offers recently published news articles highlighting metals theft.

For law enforcement, there is a *Glossary of Common Materials Processed by Recycling Companies*. The glossary will aid in metals identification by defining industry terminology in layman's terms. Along with the definitions are photographs of metals to further assist in identification. The law enforcement tab also identifies the current members of the Law Enforcement Advisory Council and offers links to ScrapTheftAlert.com and *BOLO News*.

In addition to the information available to law enforcement, the prosecutor tab provides a link to specific state laws and other metals theft resources on a state-by-state basis. A list of "Frequently Asked Questions" regarding the fight against metals theft is also available.

For recyclers, the site offers several versions of compliance posters made available by ISRI and a poster of common Regulated Items. Also available to recyclers is a list of best practices to avoid being victimized by metals theft. The list, *Recommended Practices and Procedures for Minimizing the Risk of Purchasing Stolen Materials*, helps recyclers avoid the financial risk and penalties of inadvertently purchasing stolen materials.

The site will be updated on a continual basis.
