Copper Theft: A Crime of Opportunity



One factor to consider when examining the continued problem of metal theft, and specifically copper theft, is easy accessibility to an abundance of copper. Copper theft is often times a crime of opportunity. Anywhere copper is visible or known to be accessible, is a target. This, combined with continued high prices, currently hovering around \$3.00 per pound, makes copper an attractive target for thieves.

Law enforcement is reminded that thieves often prey on easy targets such as vacant businesses or homes empty due to foreclosure. Thieves cause tremendous amounts of collateral damage when ripping copper pipes and wire from ceilings and walls. No one or place is immune. Copper downspouts have been stolen from churches and copper coils removed from school and business air conditioning units leaving them beyond repair. Copper wire and bus bars are stolen from utility substations often times leaving homes and businesses without power. Utilities and railroads often fall victim to copper thieves due to easy accessibility and a perceived lack of security measures.

Crime Prevention units of law enforcement agencies and officers on patrol can help combat metals theft by making citizens and business, especially those in high crime areas, aware of prevention techniques. These range from enclosing air conditioning units in wire cages to storing construction materials in secure areas. Additional tools for law enforcement can be found at StopMetalsTheft.org.



ScrapTheftAlert.com Update

Eight states have metals theft statutes requiring recycler registration with some form of notification system. Five states, Colorado, Michigan, New Mexico, Ohio, and Washington, specifically name ScrapTheftAlert as an appropriate or required system. ScrapTheftAlert.com is an effective tool, but requiring recyclers to register might be only half the equation. Registration by more and more law enforcement officers combined with recyclers would make the system even more
