New ScrapTheftAlert.com Launched

A major redesign and upgrade to the ScrapTheftAlert.com (STA) system was launched for the first time this weekend that includes features designed to make the system easier to use while expanding functionality.

STA has been in operation since 2008. While the system has had many successes generating arrests across the nation, limitations in the system required an upgrade. As a result of user feedback ISRI received from law enforcement, the STA upgrade was initiated in August 2013. Without going into too much detail at this point, as you can now experience it for yourself, the following is a sample of what the new STA offers:

- Easier user interface for registering and submitting alerts;
- Ability to select multiple locations to receive alerts;
- Enhanced customizable search capabilities by material, region, date, and key words;
- Extractable search results to Excel;
- Additional materials categories added to include vehicles and batteries;
- Increased capacity for the downloading of additional images and information;
- Ability to post success stories;
- Capability for future expansion; and
- Restricted portion of the site for law enforcement, with enhanced features.

Though transfer to the new system is expected to be seamless for most users, by allowing law enforcement to post sensitive and private information, ISRI must have a consistent method in place to verify the credentials of any person accessing this portion of the site.

This will be the subject of a future email to law enforcement once the new STA is operational.
