

# 2022 ISRI Membership Renewal Payment Plan



*\*Please note due to Covid-19, forms will be processed weekly. We greatly appreciate your patience.*

For your 2022 ISRI membership renewal, you may choose to pay your annual dues in up to four (4) installments that will be auto-debited from the credit card you provide to us. To take advantage of a renewal Dues Installment payment plan, please complete and return all sections of this form along with your invoice to ISRI at the address below by no later than December 31, 2021. If you elect a Dues Installment payment plan, all dues must be paid in full by no later than April 2, 2022 to complete payment of your dues.

Payments will commence on January 2, 2022 and continue on the first day of each subsequent month until the dues are paid in full as of April 2, 2022. For forms postmarked before December 31, 2021 but received after the deadline, the first payment will be processed upon receipt of this form, with the remaining payments processed according to the terms above. **You must enroll with a credit card with an expiration date greater than April 2, 2022.**

Should any authorized charge by ISRI be declined by your credit card company, ISRI will attempt to contact you via email and the telephone number you provided to secure an alternate form of payment. I agree that I will promptly provide ISRI with a different credit card to apply payment. I further acknowledge and agree that ISRI may terminate my company's membership for non-payment if there is any outstanding dues balance on or after April 2, 2022 and that no refund will be issue to me or my company for any previously paid amounts.
